

Record Withdrawal Spurs Natural Gas' Weekly Price Surge

The U.S. Energy Department's latest inventory report showed a higherthan-expected decrease in natural gas supplies. Following this encouraging data, futures ended the week nearly 7% higher. However, natural gas is expected to remain volatile, depending on the temperature outlook, supply/demand balance etc. In such a situation, investors should focus on resilient stocks like Cheniere Energy LNG, Coterra Energy CTRA and EQT Corporation EQT. Stockpiles held in underground storage in the lower 48 states fell by a record 190 billion cubic feet (Bcf) for the week ended Dec. 6, above analysts' guidance of a 165 Bcf depletion. The decrease, fourth in succession, compared with the five-year (2019-2023) average net decline of 71 Bcf and last year's decline of 72 Bcf for the reported week. Bears Tighten Grip Amid Warmer Weather Forecasts

Natural gas futures drop as production holds steady at 103.8 Bcf/d, keeping bearish pressure on prices amid weak demand. Warmer weather forecasts slash near-term heating demand, with models showing sharp losses of up to 26 HDDs, per NatGasWeather. Key technical levels near \$3.090 and \$2.993 may break; traders watch closely as prices face further downside risks. Bears maintain control as oversupply concerns and weak weather-driven demand limit natural gas price recovery this week.

Southern U.S. sees highs in the 60s-70s this week, suppressing demand, while mild conditions persist in the Northeast. U.S. natural gas futures dropped sharply on Monday, opening with a downside gap as bearish fundamentals weighed on the market. Production remains elevated, with Wood Mackenzie estimating output at... Can Weather Volatility Reverse the Bearish Market Outlook?

Colder weather drives natural gas prices higher, but warming forecasts challenge market momentum late in the week. U.S. natural gas futures see a 6.63% weekly gain as traders react to record storage draw and shifting weather trends.

Record storage draw boosts bullish market sentiment. Analysis highlights resistance at \$3.444 and support at \$3.118 as critical levels for natural gas futures this week. LNG exports rise above 14 Bcf/day, supporting demand as production remains robust at over 104 Bcf/day. U.S. natural gas futures saw a roller-coaster ride last week, with a colder weather forecast and a significant storage draw driving early gains, followed by a late-week retreat due to warming weather projections. The front-month January Nymex contract settled at \$3.280, up 6.63% for the week, ... For more info go to https://tinyurl.com/5fvjzhk8




